Noise Source: Team Ortho Foundation has requested a sound level variance, at no specified sound level limit, to provide the use of a sound system for announcements at seven (7) Locations, as listed above, starting and ending at CHS Field, 360 Broadway Street for the 2017 Get Lucky Run. The variance is requested for the hours of 8:00 a.m. to 1:30 p.m., with a pre-event sound check at 7:45 a.m. on Saturday, March 11, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) the variance shall be for the hours of 8:00 a.m. to 1:30 p.m., with a pre-event sound check at 7:45 a.m. for the Get Lucky Run Event on Saturday, March 11, 2017 at seven (7) Locations, beginning and ending at CHS Field, 360 Broadway Street. Other locations are: Jackson and Shepard; Ontario and Shepard; Randolph and Shepard, Otto and Shepard; West of Otto (400 Feet prior to the 35E Underpass) on Shepard; Alton and Shepard. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:30 p.m. on the date of the event.
