A little background, Jason Holm of Rejuvenate Homes had applied for a Request for Reasonable Accommodation as a sober home. One of the requirements is that parking is met and for the number of residents they were proposing, six spaces were required. They had showed on a parking plan three (3) spaces in the rear and three on the street which meets the code. See requirement #5 on the letter.
