Per your conversation with Ms. Moermond at your legislative hearing last Thursday, April 16, she communicated staff would email the recommendation going to City Council on June 3, 2020. Her recommendation is as follows:

Delete the assessment for Quarter 4, 2019 (This is the one you formally appealed)

Staff to delete assessment for Quarter 3, 2019, and reduce pending Quarter 1, 2020 assessment from \$77.36 to \$25.79.
