It is our understanding that the Nova Classical Academy is in the process of planning for their new school building to be located across from Kay Avenue, in between Pearlman St. and Otto Ave.

Sholom as an organization supports the mission and values of the Nova Classical Academy and we are looking forward to having a school close by – both students and seniors alike would benefit from intergenerational programming. We look forward to developing a partnership with the Academy.

However, we regret that Sholom was not included as partners in the earlier planning stages for the school, and the proposed changes to the Master Plan for the neighborhood. Sholom is not supportive of the current proposed location of the new school building because of the reasons listed below. We would like our representatives to be able to participate in discussions with the school and the city to find a way to come to an agreement that will meet the schools needs and our requests.

Sholom's three main concerns are:

- 1) The view of the river and the bluffs will be blocked from Bentson Family Assisted Living tenants. Current plans for the school will have tenants on south side of the building looking at the back and top of the school.
- 2) Available street parking spaces are already filled daily. With the addition of the school, there will likely be problems for tenants, families, and other visitors finding any spaces at all.
- 3) Because of increased traffic in the area, there will be increased risk of danger to our tenants, residents, and their families.

We would like the school to alter their current planned location so that the school building won't obstruct Sholom residents' and tenants' views, and so that possible parking and traffic issues will be controlled.





