Section (20) On any street or alley, at the same location, for more than 48 consecutive hours. FOUND VEHICLES PARKED ON THE CURB CUT/BOULEVARD AREA OF THE PROPERTY. PLEASE REMOVE AND KEEP ALL VEHICLES OFF OF THE BOULEVARD/CURB CUT AT ALL TIMES.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on **January 22, 2019**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**² and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal and pay a filing fee.)
