Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled on **Wednesday**, **December 7**, **2016** at **5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

This is an uncontested matter concerning the fact a Saint Paul Police Officer, posing as a patron, was allowed to leave the licensed premises with an alcoholic beverage during a compliance check on September 15, 2016 (CN #16-188-409) in violation of Saint Paul Legislative Code § 409.08 (15).

Per Saint Paul Legislative Code § 409.26 (b) (9), the licensing office will recommend a \$500.00 matrix penalty. In addition, they recommend three (3) new license conditions be placed on the license.
