*Referred to Legislative Hearings August 8. Attorney committed to posting performance deposit and has found a representative of the estate. Moermond committed to adding language stating that the performance deposit will be returned in the event that the property is rehabilitated in the form of demolition.*

*Marcia Moermond, Legislative Hearing Officer: My recommendation coming into today's meeting was to order the building removed, with no option for its rehabilitation, as no performance deposit has been posted and no code compliance inspection has been applied for. I have been meeting with the attorney representing the mortgage company, and am asking now for this to be referred to Legislative Hearings next Tuesday. She has committed to post the performance deposit. I have committed to add a clause to the resolution which confirms the Department of Safety and Inspections policy to return the performance deposit in the event that the owner pursues demolition and that it's deemed that the property is rehabilitated. The attorney has today identified a representative of the estate. We have been working on this for 6 months, and that had not yet happened. That is great for her company as well as the City.*

*Council President Brendmoen: Is the attorney here to testify?*

*Moermond: She is here to answer questions if need be.*

*Brendmoen: No questions. Just wanted to check.*

*Marcia Moermond, Legislative Hearing Officer: This is one of the worst nuisance properties I have seen in a while. It has significant neighbor, police, and code enforcement issues. It has been broken into and squatted in. During the first Legislative Hearing at the end of June, the Vacant Building Supervisor stated concerns about break-ins into the garage by homeless people and that it was an urgent problem. The following day there was an explosion and the garage burned down. No one was hurt. The neighboring garage and some trees were damaged and ordered removed. Wires needed to be dealt with by Xcel Energy. The house has structural problems in the basement, such as significant cracks in the wall. To refer this back to Legislative Hearing, I would ask that a performance deposit be posted, a code compliance inspection be requested, and require a structural engineering analysis. During the first hearing, the attorney said that one was anticipated within the next two weeks, which would have been two weeks ago. I got it in my email this morning and will share it with the City's structural engineer. I'm not 100% confident in it. If the cover letter is addressed to the wrong person, you don't necessarily trust the facts that follow. This particular report speaks to the City of Arden Hills, so that does not make me feel confident about the attention to detail that one looks for from an engineer. That said, all 3 things have been done by the owner. I did not commit to make a recommendation one way or another, based on those things being done. I am not confident that the current owner has control of the site. I have briefed Councilmember Yang. There is no code compliance report yet. It was requested last week. The Department of Safety and Inspections is expediting it, and I expect it will be here next week. Based on that, along with the engineering analysis, I think I can give you a better report. I think the bank may have better information, also. I don't think prospects are good, but I wouldn't rule it out. There are testifiers today as well as a good amount of testimony in the record.*

*Council President Brendmoen: It sounds like there are lots of concerns here, but you did get some stuff in your inbox today. I know Councilmember Yang also wants to be present for this final vote and has concerns. Maybe a one week layover would give that time to review the new materials and for Yang to be here.*

*Kristina Kaluza: I am agreement with what was just said. I heard from the building inspector that he is hoping to get there on Monday. Hopefully the report will be ready by next Wednesday. The owner has put down the performance deposit. Since this is bank-owned, there are financial resources available for demolition or repair, once we review the two reports. The bank is also soliciting bids to make a determination on that.*

*Brendmoen: We are looking at a one week layover and it sounds like you are in support of that.*

*Kaluza: Yes. Once a recommendation is made, will we have a chance to respond to that?*

*Brendmoen: We will keep the public hearing open so you can get a chance to speak next week.*

*Hanna Getachew-Kreusser: Darius Husain and I have a number of concerns and some possible solutions. We would like to potentially use this space.*

*Darius Husain: We just wanted the Council to be aware that there is a grades 9-12 charter school on the other side of the fence from this property. We have been dealing with this nuisance for a long time. Having this right next to our students has been difficult. Right next to the property is a garden space with crops, an outdoor classroom, and a memorial space. It is our hope that the Council continues the pressure to ensure a positive outcome for this space. In the last week, we are encouraged by activity the bank has done since they became aware of everything happening. We know this is privately owned, but we would like to help develop the land if the property is to be demolished. We would like to use it to expand the school and/or the health clinic if it is not rehabilitated.*

*Brendmoen: It sounds like this could go one way or the other.*
