## **NOTICE OF PUBLIC HEARING**

### Sound Level Variance – Monster Dash Start Cathedral Hill Park and Summit Avenue

Dear Saint Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** Event will be located at Cathedral Hill Park and Summit Avenue to Start Line, 400 Feet East of Nina Street

**Noise Source:** Team Ortho Foundation, Monster Dash Event Start has applied for a sound level variance in order to provide a Mobile Stage, DJ and use of Speakers at the Monster Dash Event Start, Cathedral Hill Park and Summit Avenue to Start Line, 400 Feet East of Nina Street for their Event on Saturday, October 25, 2014 from 7:30 a.m. to 9:00 a.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 7:30 a.m. to 8:30 a.m. for Cathedral Hill Park with a Mobile Stage, DJ and Speakers, and from 8:00 a.m. to 9:00 a.m. for Summit Avenue 400 Feet East of Nina to Selby for use of Speakers on Saturday, October 25, 2014. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for amplified music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 a.m. on Saturday, October 25, 2014.
