Requested Board Action

Approve lease agreement with New Cingular Wireless PCS, LLC (Cingular) for space at the

Kellogg Parking Ramp for the purpose of placing and maintaining communications equipment.

Background

Cingular requests to renew a lease agreement with the HRA to lease space at the Kellogg

underground parking ramp to install an antenna and maintain related equipment for

communications purposes. Cingular has been leasing this space since 2009. This equipment helps

provide 4G and eventually 5G cellular service for the RiverCentre complex and does not interfere

in any way with the operation of the ramp.

Lease terms:

Rent for the initial ten-year term will be \$600 per month. There will be two five-year extension

terms, with rent \$690 per month for the 1st extension term, and \$793.50/month for the 2nd extension

term. At the end of the extension terms the lease is year-to-year with a 3% increase each year.
