Please take notice that this matter has been set on the Public Hearing Agenda for a City Council meeting on **Wednesday, May 16, 2018 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed are copies of the emails you sent on May 1, 2018, indicating that you were not contesting the facts related to the incident, but were requesting the opportunity to address the Council regarding the penalty, the resolution and any supporting documents. This information will be presented to City Council for their consideration.

This is an uncontested matter related to controlled buys of synthetic marijuana made by Saint Paul Police inside the licensed premises on September 20; September 25; October 3; and November 6, 2017 and several guns and ammunition that were recovered during a search warrant executed by Saint Paul Police on November 21, 2017.

Due to the serious nature of the illegal activity you allowed at the licensed premises, the licensing office will recommend revocation of your Cigarette/Tobacco license.
