Dear Property Representative:

A re-inspection was made on your building on August 14, 2020, in response to a complaint. You are hereby notified that the following deficiencies must be corrected prior to re-inspection date.

A reinspection will be made on August 25, 2020 before 4:00 PM.

Failure to comply may result in a criminal citation or the revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

1. Exterior - Back Stairs - SPLC 34.09 (3) 34.33 (2) - Provide an approved handrail. The top of the handrail must be between 34 and 38 inches above the treads and run the entire length of the stair. -The new handrail has been installed incorrectly and is missing the return pieces at the end of the handrail rail. The handrail must be able to hold imposing loads.

You have the right to appeal these orders to the Legislative Hearing Officer.
