CORRECTION NOTICE - RE-INSPECTION COMPLAINT

Dear Property Representative:

A re-inspection was made on your building on July 8, 2025, in response to a complaint. You are hereby notified that the following deficiencies must be corrected prior to re-inspection date. **A reinspection will be made on August 1, 2025 at 11:30 AM.**

Failure to comply may result in a criminal citation or the revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

1. B-4 - SPLC 34.23, MSFC 111.1 - This occupancy is condemned as unsafe or dangerous. This occupancy must not be used until re-inspected and approved by this office.-Unit B-4 ceiling is unsafe being condemned 7-8-2025.

Unit B-4 must be unoccupied by 7-18-2025.
2. D4 - Ceiling - SPLC 34.09 (2)(b), 34.33 (1)(d) - Provide and maintained the roof weather tight and free from defects.-Ceiling leaking in D4. Find source of leak.
3. D4 - Ceiling - SPLC 34.10 (7), 34.17 (5) - Repair and maintain the ceiling in an approved manner.-Ceiling has very extensive water damage as ceiling is coming apart at sheetrock seams. Have to take down ceiling material and repair all affected material and decolorization on flooring material. Find source of water intrusion.
