Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled for **Wednesday, February 17, 2016 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed are copies of the resolution and supporting documents which will be presented to City Council for their consideration. This is an uncontested matter concerning the fact that the Minnesota Department of Revenue seized contraband tobacco products from the licensed premises during an inspection on October 20, 2015. This was the second violation for the same offense in the past three (3) months. Due to the severity of the repeated violations, the licensee office will recommend an upward departure to a five (5) day suspension of your Cigarette/Tobacco license.


