**NOTICE OF PUBLIC HEARING**  
Sound Level Variance – June 13, 2015  
Kelly O’Shaughnessy Wedding

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

**Description of Variance:**

**Location:** 702 Fairmount Avenue

**Noise Source:** Kelly O’Shaughnessy has requested a sound level variance in order to present amplified music with Sonos speakers from 4:00 p.m. until 11:00 p.m. for wedding music on June 13, 2015 at 702 Fairmount Avenue. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified speaker music for the hours from 4:00 p.m. to 11:00 p.m. on Saturday, June 13, 2015. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA at 50 feet from the noise source from 4:00 p.m. until 11:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:00 p.m. on Saturday, June 13, 2015.
