My name is Mary Kaye. I work for Raven Financial, LLC and represent them for the purposes of the April 3, 2013 hearing regarding 758 Maryland avenue east. The attached email was submitted by the City of St. Paul for public record in March of 2013 in the matter of nuisance abatement.

I am submitting this information to contest the legitimacy and possible intent of fraudulence on the part of the City of St Paul. This email was submitted as public record by Mai Vang. It is a response she is sending me regarding my submission of Documents requested by Marcia Moermond.

An email can exist in one of three states. An email can be "Sent", "Received", or "Composed". Every email that is "sent" includes a time and date stamp which is an automatic function of the server that creates an audit trail. An email that is "Received" also contains a time and date stamp. An audit trail is not a function that can be turned off or disabled.

The following email was submitted to public record by Mai Vang. It was submitted the last week in March of 2013. Please note that the lack of an audit trail Indicate that it is merely a composed email and that it was never sent to the parties that it was intended for. Also the record itself has a date of 2-27 in the name.

This indicates that Mai Vang Composed and submitted this email in late March to public record with the intent to make it appear as though she responded to my email of February 26<sup>th</sup>. Mai in fact did not respond to my email, it could appear as though from the evidence that it is merely manufactured after the fact as evidence.
