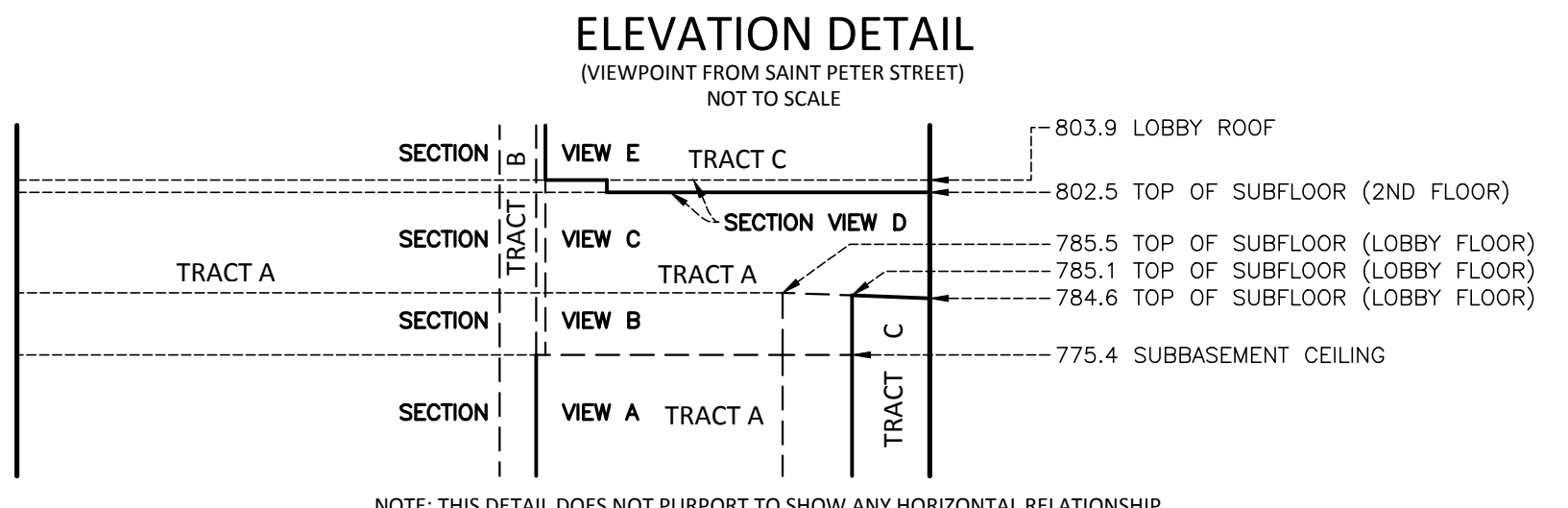
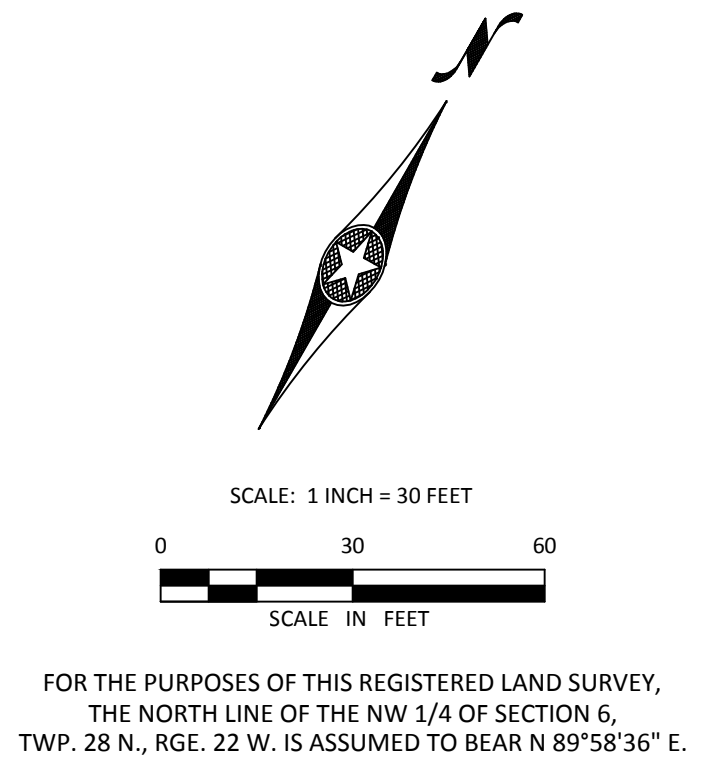
SECTION VIEW D

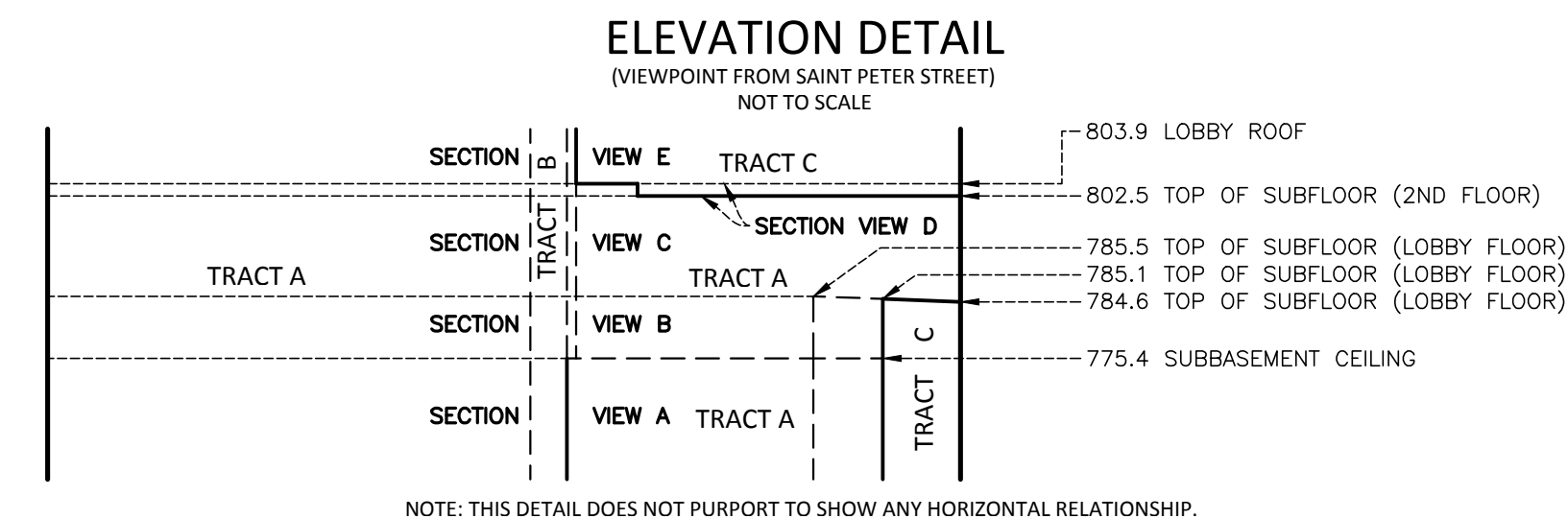
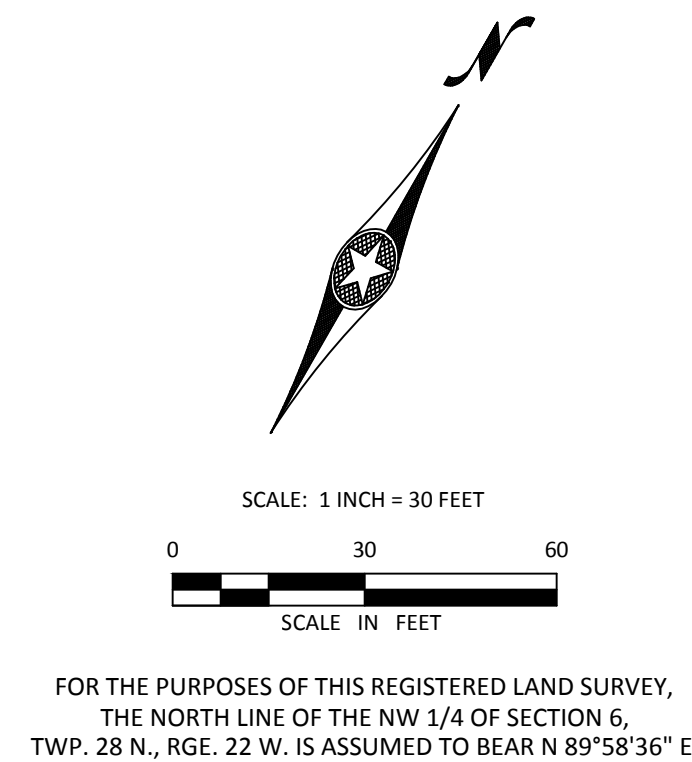
SECTION VIEW A
