## **CORRECTION NOTICE**

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **June 04, 2024** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

- 1. SPLC 65.141. **AUTO REPAIR:** Auto repair is not permitted in a residential zoning district per St. Paul Legislative Code (except for vehicles registered to residents of the property.) Immediately cease all commercial auto repair operations and remove all vehicles not belonging to resident of this property. REMOVE ALL VEHICLES THAT ARE NOT REGISTERED TO THE PROPERTY.
- 2. SPLC 157.11. **COMMERCIAL VEHICLE PARKING:** No Commercial or Overweight Vehicle shall be parked overnight or stored on property zoned residential or occupied exclusively as residential. REMOVE TOW TRUCK FROM THE PROPERTY AND THE PLOW TRUCK FROM THE FRONT YARD.
- 3. SPLC 34.08. **VEHICLES:** All vehicles must be correctly licensed, operable, secure from unauthorized entry, and parked on an improved surface. Correct violations, store in a garage or remove. ALL VEHICLES MUST BE PARKED IN THE DRIVEWAY, OPERABLE, AND HAVE CURRENT TABS OR REMOVE FROM THE PROPERTY. THANKS

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on or after **June 11, 2024**, by which date the violations noted must be corrected. Failure to correct these deficiencies may result in an abatement and/or additional fees for re-inspection.
