Dear Council President Brendmoen and Members of the St. Paul City Council:

I am a second-grade teacher at HCPA, and I would like to personally add on to Dr. Hang's detailed and honest reasoning and request for the Skyway authorization. I can confirm all of which Dr. Hang stated below. There is a lot of traffic on Brewster Ave, and while Dr. Hang and Mr. Yang have done everything in their power to put the safety of the children and staff first by providing each teacher a fluorescent safety vest and crossing flag, the frequency and consistency of students already crossing the street is scary. Quite honestly it is an accident waiting to happen, especially in the winter time when Brewster Avenue is horrendously icy (poorly maintained)!! This risk will only multiply when the middle schoolers need to cross Brewster to go from building to building.

By denying this skyway you are putting thousands of children's lives on the line, plus hundreds of teachers. To deny this skyway (that HCPA is paying for) would be negligent and appalling! If you are still skeptical, please read the rest of Dr. Hang's detailed informing letter. Consider the lives of children and teachers required to cross the street at a minimum of 3x per day, but upward to 5x a day.

The Phase 5 Project that HCPA is currently constructing, a new middle school on our property south of Brewster adjacent the parking lot and sports dome, has always included the Skyway to address the safety of our students and teachers, and traffic issues in the neighborhood. Our students and staff/teachers currently have to cross Brewster street every hour starting at 7:00 am to 6 pm for gym class, recess, to board the buses during arrival and school dismissal time, and to attend after school sports program that are held inside the sports dome. This creates a significant issue for traffic on Brewster throughout the day. To make matters worse, once construction is complete on the Phase 5 project, 650 Middle School students will be crossing Brewster street daily to eat breakfast and lunch, while K-5 students will cross the street every hour for recess at the sports field and playground area.
