### **Description of Variance**

**Location:** Boyd Park, 335 Selby Avenue

**Noise Source:** B Horst Productions, Beats in Boyd, has applied for a Submission 2 sound level variance, at a requested sound level of 90 dBA at no specified distance, in order to provide music outdoors at Boyd Park for the hours of 6:00 p.m. until 10:00 p.m., with a pre-event sound check from 5:00 p.m. until 6:00 p.m. on three (3) Fridays, September 7, September 14 and September 21, 2018. The Department of Safety and Inspections recommends the following conditions: 1) Variance will be for amplified music for the hours of 6:00 p.m. until 10:00 p.m., with a pre-event sound check from 5:00 to 6:00 p.m., on three (3) Fridays, September 7, September 14 and September 21, 2018. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA, as measured at 50 feet from the noise source from 6:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on each event date.
