and a taxi fleet maintenance and dispatching facility is a permitted use in this district. Both engine and autobody repair are also permitted uses in this district. AMANDA indicates the Cofo status for the building at this address is a "revoked unoccupied", since 1999. The former occupant was Minn Diversified Industries(MDI) who worked with development disabled employing these workers for light assembly type factory work. The leasing information indicates that the building has 15000 sf of office area with 98, 296 sf of factory/warehouse area. Applicant says the building is fully sprinklered.
