Dear Mr. Ogamien:

The Department of Safety and Inspections (DSI) has recommended suspension of the Dance or Rental Halls license held by Jonah Ogamien d/b/a Jonah Ogamien for the premises located at 508 Snelling Avenue North in Saint Paul. The basis for the recommendation is as follows:

On January 23, 2012, you were sent an IMPOSITION OF FINES AND ADDITIONAL LICENSE CONDITIONS letter from the Department of Safety and Inspections requesting payment of the \$2,000.00 matrix penalty imposed by City Council on January 11, 2012. (RES #12-20). The penalty was imposed due to fact that on July 2, 2011 you allowed someone under eighteen (18) to be present without a parent or guardian and allowed the sale of alcohol on the premises; and on August 19, 2011, you allowed the sale of alcohol on the premises. You were given until February 10, 2012 to pay the \$2,000.00 matrix penalty. As of today's date, it has not been paid.

You need to send the \$2,000.00 penalty payment to the Department of Safety and Inspections at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Thursday, March 1, 2012**. Information should be directed to the attention of Christine Rozek. A self-addressed envelope is enclosed for your convenience.

If you do not pay the \$2,000.00 matrix penalty or show proof of payment by **Thursday, March 1, 2012**, the matter will be on the **March 7, 2012** City Council Consent Agenda to suspend your Dance or Rental Halls license.


