1. Remove all tires, junk, metal scraps, wood scraps and discarded materials from the property area. Comply before June 16, 2017
2. **Maypop Tire shop has been condemned and ordered to be vacated immediately. Failure to comply will result in the building being vacated and secured by the Department of Safety and Inspections. Comply before June 8, 2017**

If you do not correct the nuisance or file an appeal **before June 08, 2017** , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.

APPEALS: You may appeal this order and obtain a hearing before the City Council by completing an appeal application with the City Clerk before the appeal deadline noted above or seven (7) days after the date mailed, which ever comes first. No appeals may be filed after that date. You may obtain an appeal application from the City Clerk's Office, Room 310 in City Hall, 15 W Kellogg Blvd., St. Paul, MN 55102. The telephone number is (651) 266- 8688. You must submit a copy of this Summary Abatement Notice with your appeal application.

*WARNING Code inspection and enforcement trips cost the taxpayers money.
