- 1. Deficiency with garage or other structure on the property. REMOVE ILLEGAL TENT STRUCTURE FROM REAR YARD. IT IS BEING ILLEGALLY OCCUPIED. AND DOES NOT MEET THE MINIMUM MINNESOTA STATE BUILDING CODE REQUIREMENTS. AND DOES NOT MEET CITY OF ST PAUL ZONING CODE REQUIREMENTS. REMOVE IMMEDIATELY. Comply before April 5, 2017**

If you do not correct the nuisance or file an appeal **before April 05, 2017** , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.

APPEALS: You may appeal this order and obtain a hearing before the City Council by completing an appeal application with the City Clerk before the appeal deadline noted above or seven (7) days after the date mailed, which ever comes first. The telephone number is (651) 266- 8688. You must submit a copy of this Summary Abatement Notice with your appeal application.

***WARNING** Code inspection and enforcement trips cost the taxpayers money.
