Dear Legislative Hearing Officer,

I am writing to you specifically in reference to the license application for Northern Tier Retail LLC, which does business as SuperAmerica #4358- ID#20100004249, located at 756 Snelling Avenue North in Saint Paul. This property abuts our Saint Paul campus at the southeast corner of Snelling and Englewood.

At Hamline, we have approximately 5,000 students and several hundred faculty and staff members comprising five schools, including a college of liberal arts, and schools of business, education, law, and graduate liberal studies. More than 800 of our students reside in our residence halls on campus, and several hundred more live in the neighboring community.

The license application of the SuperAmerica in question includes requests to continue to sell malt liquor and cigarettes/tobacco and to operate as a gas station, a no-seat restaurant, and a grocery outlet—all on a 24-hour, seven-days-per-week basis.

We have been in discussion with management of Northern Tier Energy, and have found them responsive and respectful of our concerns. They have indicated a commitment to expand security and to work closely with us in response to matters that occur at this store. We are committed, as well, to work with Northern Tier Energy as it implements any changes.

However, our concerns as to hours of operation and the sale of malt liquor remain.

Our students and staff, while appreciating the convenience of having a gas station/store nearby, continue to report incidents of being verbally and/or physically assaulted, propositioned, or otherwise harassed by seemingly intoxicated or threatening persons while passing by the SuperAmerica, particularly in the evening and night hours.

Our university community members are not the only ones concerned. In fact, there have been 88 police calls regarding incidents occurring at SuperAmerica itself in the past 12 months. Many of the calls were for disturbance/disorderly conduct, assault, and theft. In our experience, customers who purchase individual/single serve liquor often loiter in the area, harassing passersby, or venture onto our campus to panhandle for cash, which they then use to purchase another single serve alcoholic beverage. We would request consideration by SuperAmerica to not sell malt liquor at this location.

It seems to us the hours of operation (24/7) contribute to the challenges. Of the 88 police calls, 50 of the calls occurred between the hours of 10 p.m. and 6 a.m., and the vast majority of the calls involving violence of any kind occurred during that time frame, as well. We feel that the safety of our students and employees would greatly increase if the SuperAmerica would operate between the hours of 6 a.m. and 10 p.m.
