**Sponsors:** Lantry

*Rachel Tierney, Assistant City Attorney representing the department of Safety and Inspections (DSI), gave a staff report. She said the basis of the adverse action was a citation by a Saint Paul police officer for being on duty without a valid driver's license. The license had been suspended for failure to pay fines, and was reinstated shortly thereafter. Ms. Tierney said the Legislative Code called for taxi license revocation. She noted that Mr. Noh's driver's license had been suspended for failure to pay fines and not for traffic violations, and said the matrix penalty would be a \$500 fine if the Legislative Code didn't call for revocation. She said the staff recommendation was revocation because that was what the code called for, but reiterated that the matrix penalty would be a \$500 fine.*

*In opposition:*

*Appellant Abdinasir Noh (135 Winnipeg, #207) (via an interpreter), said he'd gotten a speeding ticket the previous July, and had rescheduled and then missed his hearing date. He said he had many roommates and didn't receive notice of the driver's license suspension. He said he was stopped by parking enforcement and informed of the driver's license suspension, and a police officer cut the driver's license and took the taxi license and car. He said he'd paid his fine and fees immediately, and his driver's license was reinstated and taxi license returned. He said he thought everything was fine until he received the public hearing notice.*

*Councilmember Carter confirmed with Mr. Noh that he hadn't been aware his driver's license was suspended.*

*Councilmember Carter moved to close the public hearing. Yeas - 6 Nays - 0*

*Councilmember Carter said driving with a suspended license was not something to be taken lightly, but Mr. Noh seemed to be recognize the seriousness and had taken steps immediately. He noted that the license was suspended for only three days before Mr. Noh was made aware of it and had it reinstated. He asked for input, but said his sense was to impose the matrix penalty of \$500.*

*Councilmember Thune recommended staying the fine for twelve months as long as there were no same or similar violations.*

*Rachel Tierney, Assistant City Attorney representing the Department of Safety and Inspections (DSI), said a \$500 fine imposed against the licensee on October 6, 2010 hadn't been paid, and the Council had just approved a license suspension on the Consent Agenda. She said the new zoning and license conditions violations being considered were very similar to the earlier ones, and staff was recommending a \$1000 penalty. She noted that these violations had taken place a couple of weeks after the previous ones.*

*In opposition:*

*Marco Martinez (204 Bates Avenue), owner of Perfect Auto Body, said he'd come into compliance after first violation, but hadn't attended the public hearing because he hadn't known about it. He said he'd called the inspector after receiving the letter about the \$500 fine and been told that there was still garbage on the property. He said he'd recently received another letter from the inspector ordering removal of the trailers, and had tried to explain to the inspector that the trailers were needed for the business. He expressed frustration that the inspector would not allow vehicles in the lot to be parked in a configuration that differed from that in the plan. He said the photographs in the file were from June. Council President Lantry said the Council did have November photographs. Mr. Martinez said the photographs didn't accurately reflect the condition in the parking lot at the time of the inspection.*

*Council President Lantry moved to close the public hearing. Yeas - 6 Nays - 0*

*Council President Lantry said she drove past the property regularly and knew what it looked like. She said she had driven past that week and called in a complaint about the sidewalk not being shoveled. She moved the recommendation of DSI to impose a \$1000 fine.*

She said DSI's recommendation was a 30-day suspension.*

*In opposition:*

*Deanna Pavolny said her husband owned the store, and she expressed apologies. She said all new employees completed an online training course in tobacco compliance, and she described store policies for verifying age. She said policies were not followed and math errors were made in this case, and the employee was new and was terminated. She said they had since invested in a scanner and instituted no-tolerance policy. She stated that over 90% of their customers purchased tobacco products, and a suspension would result in the store having to close, causing 2 full time and 11 part time employees to lose their positions. She asked that the suspension not be imposed and that they be given one more chance.*

*Councilmember Stark move close the public hearing. Yeas - 6 Nays - 0*

*Councilmember Stark said the violation was very serious, but the owners were taking it seriously and had made corrections. He said it was too bad it had taken the threat of a license suspension for changes to be instituted. He noted the testimony about economic hardship and said he recognized the difficult times being faced, but felt a license suspension was appropriate. He moved a five-day suspension with the remaining 25 days stayed for 18 months unless there were same or similar violations.*

*Council President Lantry clarified that the suspension was of the tobacco license only.*
