I am objecting to adding the \$166.63 lighting and sweeping fee as an assessment to the property taxes for my property (ID 28-29-23-22-0002). The check I sent for payment cleared my account on 10/26/20. Which was the day before I received the Notice for the ratification of assessment. I sent the check on 10/20/20. The reasons I missed the 09/30 deadline are several. First, I didn't remember that both fees (lighting/sweeping and storm sewer system) were contained in the same mailing. When I opened the envelope the one I noticed was the storm sewer fee which was due 11/15 (I combined the two in the check I sent). I made a note to meet that deadline.

I was also very distracted during this same time frame. I had a tibial and fibular artery bypass with the great saphenous vein surgery done on 07/23. That involved the removal of the main artery in my leg and replacing it with the great saphenous vein or an artificial one. I have about a 3 foot scar on my leg as a result of the procedure. I am still not completely recovered from that. Additionally, I have hemoptysis (coughing up blood). That has recently been increasing in frequency and volume and doctors have not determined the cause(s). I have had bacterial lung infections, but resolution of those did not clear the hemoptysis. I am continuing to undergo examinations for that issue hoping to reach some kind of resolution of it.

If you will examine my record, you should notice that I have never been past due in paying these fees on time. Due to the above described distractions, I am asking the council to honor my objection and not add this fee to my property tax assessment.
