Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday**, **April 20**, **2011 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the proposed resolution and other documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that during a proactive visit to your establishment on January 9, 2011, Saint Paul Police observed an employee drinking an alcoholic beverage after 2:30 a.m. in violation Saint Paul Legislative Code § 409.26 (b) (6). You offered to provide the videotape concerning the incident, but were unable to because the DVR was not plugged in that night in violation of license condition #1. This matter has been placed on the public hearing agenda portion of the City Council meeting during which public discussion is allowed. The licensing office will recommend a \$500.00 matrix penalty for the two violations and a modification to license condition #1.
