Synopsis : On 07/02/2025 at approximately 2223 hours, officers responded to 275 Sherburne Avenue on an assist medical call. The comp called and stated a (67 YOM) victim fell and hit his head fell and hit his head. The victim was unconscious and was bleeding from the head. The victim was transported by medics to Regions Hospital. Narrative : On 07/02/2025 at approximately 2223 hours, I, Officer CHING VANG (Squad 285) responded to 275 Sherburne Avenue on an assist medical agency call. My BWC was on and recording during my participation on this call. Upon my arrival, medics were already on scene and in the process of loading the victim, later identified as ALAN EDWARD GLEWWE (DOB: 11/15/1958, N/A) on the stretcher. I asked medics if they spoke to the caller and they said he had left the scene. Medic 18 (run #33084) stated the door

was unsecured and they found GLEWWE inside the doorway unconscious and bleeding from his head.

I spoke with one of the witnesses, later identified as JONAH HER (DOB: 07/11/1984, 612-213-7763, 277 Sherburne Avenue) who stated he saw a black male, wearing a red sweatshirt, black pants and a ski mask standing outside by the front door of 275 Sherburne Avenue. HER said the male kept pacing back and forth at the front door. The black male then told HER, "If the ambulance arrives, tell them it is this house and apartment." HER said the male then left on foot, walking in a fast pace east bound on Sherburne towards the light rail. HER said after the unknown black male left, the ambulance arrived two minutes later. HER also said the victim lives at 275 Sherburne Avenue and he have never seen the black male before.

With HER statements saying the black male informing him if the ambulance arrived and to direct them to 275 Sherburne Avenue, it is most likely the black male was the comp who called 911.

The house is a two-unit duplex with a lower and an upper unit. CLEWWE lives in the upper unit and was found inside his doorway by the front door. I noticed a pool of blood inside the unit by the front door, leading up to a stairway to the unit. There were also a couple of empty alcohol beverages and broken glass at the bottom of the stairway as well. I announced myself as Saint Paul Police Department and made my way up the stairs to verify if there were other occupants in the unit with negative results.

I took photos of the blood and later uploaded it to evidence.com.

Due to the information, I got from the witness "HER," and my observations of GLEWWE injuries, it is unknown if GLEWWE fell down the stairway or if he was assaulted. I advised assisting Officer F. BERHANE (Squad 272) to hold the scene while I made my way to Regions Hospital to gather additional information.

I arrived at Regions Hospital and spoke with one of the nurses and she informed me that GLEWWE condition is in critical. GLEWWE sustain a big laceration on the right forehead, fracture skull on the right head, a black eye to his right eye with it being swollen. The doctor stated GLEWWE will be going in for a CT scan and most likely to surgery on his fracture skull. A while later, the doctor told me GLEWWE will no longer be going into surgery, but he will be moved to the ICU unit for the time being. Sgt P. LEE was advised of update.

I tried interviewing and speaking with GLEWWE for additional information on how he sustained his injuries but due to his injuries and him being sedated, he was unable to speak to me about the incident.

I took photos of GLEWWE injuries and later uploaded it to evidence.com.

The nurses collected GLEWWE clothing and bagged it up for evidence. It should be noted, in one of the packages (#2) (bag 2 of 4); it is labeled "knife" on it. Due to safety precaution, I broke bag #2 and repackaged it inside a knife box for safety measures. I later turned in all evidence into the Saint Paul Police Evidence and Property Room. I scanned and uploaded the chain of command paperwork from Regions Hospital to evidence.com.

On 2025-07-02 at approximately 22:23 hours, I, SQD F. Berhane, was dispatched to 275 Sherburne Ave for a medical call that was possibly related to an assault. Upon arrival, a male later identified as ALAN was located at the bottom of the stairwell with visible injuries to his head. Medics on scene transported ALAN to Regions Hospital for further evaluation and treatment. Refer to the primary incident report for additional medical details.

While canvassing the area, I observed a security camera mounted on the lower unit of 273 Sherburne Ave. I made contact at that residence and spoke with a tenant, identified as HOWARD. HOWARD described ALAN as a quiet individual who generally does not cause problems but noted that ALAN has a known issue with alcohol. HOWARD stated that ALAN previously fell down the stairs due to intoxication. He also mentioned that ALAN frequently brings guests to stay at his apartment without the landlord's permission.

HOWARD provided access to the security camera footage, which only captured the arrival of medics and ALAN being loaded into the medic rig. No footage of the incident itself was available or footage of anyone else leaving the address.

Residents at 277 Sherburne Ave reported seeing a Black male, approximately 5'8', wearing a red sweatshirt and a face covering, pacing in front of 275 Sherburne prior to medics arriving. The unknown male told them that medics were responding for someone at 275 Sherburne, then walked eastbound on Sherburne Ave. Moments later, medics arrived on scene.

While reviewing additional CCTV footage from the night prior (2025-07-01 at approximately 2300 hours), I observed a Black male entering 275 Sherburne Ave who may be the same individual who left the scene before the arrival of medics.

While officers were still on scene awaiting an update on ALAN's condition, it was discovered that the 911 caller was the unknown Black male seen earlier. He had used ALAN's cellphone to contact 911 and reported that ALAN had fallen down the stairs. The male did not provide his name to dispatch but identified himself as ALAN's 'roommate.'

After receiving confirmation that ALAN did not have life-threatening injuries, I contacted Data to request a board-up crew to assist with securing the front door, which had been forced open by medics during their entry. Once the front door was secured, I cleared the scene.

On 7/02/2025 at approximately 2300 hours I, Sgt A. Lopez (200), responded to 275 Sherburne Ave, to assist Sgt Lee (200) with supervising the scene where a male sustained significant trauma to the head and was transported by SPFD medics to Regions hospital. The condition of the male was unknown, and the residence was being held while we awaited word of the male's condition.

It was learned the complainant, who called to report the male had fallen down the stairs, was the person of interest and/or possible suspect. The complainant used the phone of the male, identified as Alan Edward GLEWWY (DOB: 11/15/1958), to call 911 to report the incident.

For evidentiary purposes, and to gain a better understanding of what happened, I called to the Ramsey County Emergency Communications Center (ECC) and asked if the 911 audio could be obtained. Per the ECC supervisor, I was sent the 911 audio to my department email. I uploaded the 911 audio to evidence.com (Axon).

Upon listening to the 911 Audio, it appeared the male who called was in the stairway with GLEWWY. The unknown male stated GLEWWY fell down the stairs, identified himself as the roommate of GLEWWY, but did not give out his name. The unknown male stated to have not witnessed the fall, and gave details about GLEWWY's injuries to the operator.

The unknown male sounded distressed on the recording, in regards to GLEWWY's condition.

It should be noted the phone used to call 911 was GLEWWY's and not with him at the hospital.

It should be noted I did a walkthrough of the unit (275 Sherburne) with Sgt Lee, and found no signs that an altercation occurred.

On 07/02/2025 at about 2318 hours, I (Sgt P. Lee), squad 201, was informed by squad 285 (Ofc C. Vang) of the following.

-Officers responded to an assist medical call at 275 Sherburne Ave. Officers arrived and SPFD medics already loaded the victim (ALAN EDWARD GLEWWE DOB 11/15/58) onto their gurney getting ready to transport him to the hospital.

-Squad 285 spoke with a neighbor at 277 Sherburne Ave who told him, a suspicious male described as a Black male, wearing a facemask, red sweatshirt, and black pants had been pacing in front of 275 Sherburne Ave. This black male told the neighbor if medics responded that it was for 275 Sherburne Ave. This black also told the neighbors to tell medics that 'he' referring to ALAN had fallen. The neighbor at 277 Sherburne observed this black male leave on foot prior to SPFD medics arriving. Please see 285's report for additional details.

-Squad 285 followed medics to Regions Hospital and learned from hospital staff that ALAN was in critical condition. ALAN sustained head trauma which hospital staff stated could have been caused from blunt force trauma or a hard fall. ALAN's injuries consisted of a laceration to the right side of his head, swollen right eye, and blood coming from his nose.

I instructed squad 285 to remain at the hospital and to update me on ALAN's condition.

I learned squad 272 (Ofc F. Berhane) was at the call location, 275 Sherburne Ave. I spoke to 272 who advised she spoke to the downstairs neighbors at 273 Sherburne Ave who stated the following.

-He heard a commotion in the stairs leading to the upper unit (275 Sherburne Ave). A short time later, medics arrived to tend to ALAN.

-Officers noted SPFD forced the front door to 275 Sherburne Ave to open prior to officers arriving on scene. There was a pool of blood and broken glass on the bottom of the stairs. It should be noted that 275 Sherburne Ave and 273 Sherburne are one structure. 273 Sherburne is the first level, and 275 Sherburne is the second level with its own front door access. Please see 272's supplemental report for additional details.

-Officers learned ALAN lives with two other roommates. The first roommate moved out and the second roommate was known to not be around much at the address. The landlord's contact information was obtained by squad 272.

Squad 200 (Sgt A. Lopez) and I responded to 275 Sherburne Ave. I observed the address to have an open front porch. The door leading to the stairs to 275 Sherburne Ave was not on the door hinges. There was a pool of blood at the bottom of the stairs along with broken pieces of glass

bottle(s). There were a couple of bottle of unopened glass bottles of alcoholic beverages laying on the lower steps of the stair. Squad 200 and I conducted a walk through of 275 Sherburne Ave and we did not observe any apparent signs of a struggle. A walk through of the entire exterior of 273/275 Sherburne was done as well and nothing suspicious noted.

As new information became available, I learned from squad 272 that ALAN was known to be an alcoholic and fell down the stairs in a similar fashion about a year ago.

Squad 272 was instructed to call the landlord and attempt to locate the names and contact phone numbers for the roommates. Squad 272 called the complainant's phone number (952-688-9228), did not get an answer and eventually went to a voice mailbox for "Al" who is possibly ALAN. There was no cell phone on scene or at the hospital. See her supplemental report for additional details.

Squad 212 (Ofc I. Emberley) assisted with canvassing the block for cameras. Squad 212 assisted with following up with the responding SPFD medics. See supplemental report.

Squad 200 assisted with contacting the Ramsey County ECC for the 911 audio call. See supplemental report.

I walked over to 277 Sherburne Ave which was located directly across the street from 273/275 Sherburne Ave. I spoke to an unidentified Asian female and Asian male who stated the following.

-They were hanging out outside of their address. They did not hear or see anything suspicious from 275 Sherburne Ave. They did not see anyone outside of that address as well. A short time after hanging out, they observed SPFD medics arrive and transport ALAN. They did not know ALAN. Please note that the Asian female was intoxicated, and I had a difficult time tracking what she was saying. The Asian female and Asian male stated the police could follow up with them later if needed.

Squad 200, other squads and I held 275 Sherburne Ave for further investigation until we learned from squad 285 that ALAN would live however his condition remained critical.

Squad 910 (Watch Cmdr D. Johnson) was notified and updated throughout this call.

The scene was processed/photographed and released. See officers' report.

Squad 285 was relieved from the hospital and squad 214 (Ofc J. Walsh) remained at the hospital to monitor ALAN's condition at the time of the writing of this report.
