**Why are you interested in serving on a board or committee?**

As a member of the Macalester Groveland neighborhood and a young, minority attorney employed at a long-standing St. Paul non-profit, I believe I will bring an energized and creative mindset to this advisory body.

**What skills/training or experience do you possess for the committee(s) for which you seek appointment?**

A few years ago, I served as part of a USDA-funded multinational research team that developed a sustainable agribusiness project for the rural community of Borko, Mali. I helped draft a sustainable agricultural policy for l'Institutd'Economie Rural and the Malian Agribusiness Center that both respected the local community's customs and satisfied their nutritional and financial needs. As a resident of St. Paul, I am invested in understanding how municipal planning can reshape and alter the identity of a community. Development work was a strong research inquiry during my work in Mali. I believe in the promotion of growth while at the same time maintaining the integrity of what define our communities. If appointed, I would bring a comprehensive ability to address these types of situations to the Planning Commission.

Additionally, my ability to promote change as a criminal defense attorney for the Neighborhood Justice Center, Inc. is inherently limited to a reactionary environment. While NJC's mission is to assure that low income St. Paul community members have their constitutional rights upheld in the criminal justice process, the organization is mainly limited to helping individuals once they have entered the system. The Commission's advisory capacity carries the ability to have proactive discussions that promote economic development and revitalization. My professional role permits me to voice for organizations and businesses in areas where development and stimulation are needed.
