## NOTICE OF INTENT TO REVOKE LICENSE

Mark D. Mailer 362 – 6<sup>th</sup> Avenue North South St. Paul, MN 55075

RE:

Taxicab Vehicle license held by Mark D. Mailer d/b/a Mark D. Mailer for the City of Saint Paul License ID #: 0030276

Dear Mr. Mailer:

The Department of Safety and Inspections will recommend revocation of the Taxicab Vehicle license held by Mark D. Mailer d/b/a Mark D. Mailer for the City of Saint Paul. The basis for the recommendation is based on the following information:

On February 11, 2011, during a routine check of your Driving Record with the Minnesota Department of Vehicle Services for license renewal, the Department of Safety and Inspections (DSI) discovered that your license had been suspended on October 11, 2010 for "Failure to appear of pay fines".

A subsequent check of your Driving Record on February 24, 2011, indicated that your license was still suspended. When a DSI Inspector attempted to contact you regarding this issue, he found your phone was disconnected.

This is a violation of Saint Paul Legislative Code § 376.16 (e) (5) (h) Requirement of valid Minnesota or Wisconsin driver's license which states: "Any time that a licensee's Minnesota or Wisconsin driver's license is suspended, revoked or canceled, his or her taxicab driver's license shall likewise be immediately suspended, revoked or canceled. No person shall operate a taxicab without a valid Minnesota of Wisconsin driver's license."

At this time, you have two options on how to proceed:

1. If you wish to admit the facts but you contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by Friday, March 11, 2011. The matter will then be scheduled before the City Council for a public hearing to determine whether to revoke your license. You will have an opportunity to appear before the Council and make a statement on your own behalf.

2. If you <u>dispute the facts</u> outlined above, or wish to present evidence that the conviction is not related to your license as a taxicab driver, or that you have been rehabilitated pursuant to Minn. Stat. §364.01 et seq, you may request a hearing before an Administrative Law Judge (ALJ). At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation. If this is your choice, please advise me no later than **Friday**, **March 11**, **2011**, and I will take the necessary steps to schedule the administrative hearing.

If you have not contacted me by Friday, March 11, 2011, I will assume that you do not contest the revocation of your license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
