Thank you for reaching out to the city of Saint Paul about your garbage bill. Our records indicate you had extra bags out on July 18 and Sept 6, which resulted in the charges you see on your invoice. Extra bags are \$4.00 each, plus taxes and fees. If garbage bags are present in or next to your cart, it is not possible for us to remove the charges.
