Hello Jaye,

We've received your request to change the size of your garbage cart at the address 2099 Suburban Ave, St. Paul, Minnesota, 55119.

After we spoke yesterday, I got a chance to look in your account, and I found some notes that was left on your files back in August 2025.

So instead of delivering cart size 35-gallons weekly pickup, I am ordering you a cart size 35-gallons Every Other Week pickup because you said you don't accumulate much garbage. Please let us know, reply to this email or call us if this 35-EOW cart is good for you.

Here are the notes below

"STP Solid Waste Worker: Check for garbage and recycling carts at this property. Record size and quantity. If there are no carts, deliver one 64-gal garbage and one 64-gal recycling cart **PER UNIT** and record those quantities. Attach notification to the carts explaining why they are being delivered. Thank you!

Internal Note: A letter went out to property owners who had no cart information on file, asking them to report cart status to the City. Owners who did not respond and who do not have carts at the property are getting 64-gal carts delivered.

Left VM explaining why we delivered a cart to the property and that participation in garbage service is required. Let him know to call back if he would like to swap the 64-gal cart for a 35EOW to save money."

Every-other-week carts have a purple lid to denote biweekly collection. These carts are currently backordered, and we expect to receive them in early January 2026. We will complete cart exchange for these in the order we received the request, as soon as those carts arrive. Please continue to use your existing cart until we have completed this exchange.

Cart to be Removed: Medium (64 gallons)

Cart to be Delivered: Small (35 gallons) - EVERY OTHER WEEK (garbage only)

Garbage cart size changes will result in a change to billing. On your the next quarter's garbage bill after the size change, you will see pro-rated amounts for the number of weeks at each cart size. For rates, visit stpaul.gov/garbagerates.

Please note that cart size can be changed once per year for no cost. There is a \$40 fee for additional size changes within the same year.

Hello Jaye,

I am following up on the garbage bill for 2099 Suburban Ave.

We will exchange the medium (64 gallon) garbage cart for a small (35 gallon) garbage cart with every-other-week collection within the next three weeks. The cart exchange is tentatively scheduled for Wednesday, December 31, weather permitting.

Once we have exchanged the cart, you will see a pro-rated amount on the garbage bill for the next quarter. However, we cannot change the amounts due from the time period you have had the medium (64 gallon) cart. Notice was provided prior to the cart delivery, including two phone messages offering the opportunity for us to deliver a different cart size, but we did not receive a response that would have allowed us to do so. Because of that, we can only change the rate going forward after the cart size is exchanged.

Once you receive the new cart, it will be collected every other Wednesday. A collection calendar for the rest of 2025 is attached which shows the weeks collection will occur.

Additional information about garbage rates is available at www.stpaul.gov/garbagerates.

Please ensure the garbage cart is out by 6 a.m. on your collection day during the next few weeks so that we can exchange it. Cart size changes are completed by a different team than the one that empties the garbage cart.
