**Location:** SPYC Lower Harbor on Harriet Island

**Noise Source:** Diane Scovill, Saint Paul Yacht Club, Social Chair, has requested a sound level variance, for no specific dBA or distance, to present amplified sound with use of a sound system for the SPYC Luau event, on August 26, 2023 at SPYC Lower Harbor on Harriet Island. The variance is requested for the hours of 6:00 p.m. to 9:00 p.m. with a pre-event sound check from 5:00 p.m. to 6:00 p.m. on August 26, 2023. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 6:00 p.m. to 9:00 p.m. with a pre-event sound check from 5:00 p.m. to 6:00 p.m. on Saturday, August 26, 2023 for a SPYC Luau. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA at 50 feet from any sound source on August 26, 2023. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 p.m. on August 26, 2023.

**Submit comments for Public Hearing electronically.** The public may comment on public hearing items in person, in writing or via voicemail. Any comments and materials submitted by 12:00 pm of the day before the meeting, Tuesday, August 22, 2022, will be attached to the public record and available for review by the City Council.
