Subject: Riverview corridor

Hello Councilmember Chris Tolbert,

This is Charles Decker, a St. Paul resident at 2106 Eleanor Ave. I see you are on the Riverview Corridor Policy Advisory Committee. I would like to share with you my opinions about the current proposals.

Today (8-16-17), I talked with Kevin from the Riverview Corridor study/Ramsey County. I was surprised that they weren't knowledgeable about the original proposal for the B-Line which was to be like the current A-Line but the B-Line would travel down West Seventh to the Mall of America. They said they were not familiar on the specifics of the B-Line. They could not tell me

the difference between the original B-Line and the BRT for the Riverview Corridor. I had to come home and look it up for myself.

I've put links to my references for the facts presented here at the bottom of this email:

B-Line BRT: \$28 million start up cost; Running time: 34 minutes
BRT Riverview corridor style: \$75 million start up cost; Running time: 39 minutes
Streetcar: \$1 billion and very slow at 43-44 minutes

I don't know what extra amenities that 50 million would get because they couldn't tell me. The most important part is the five minutes difference between the B-Line and the Riverview BRT. Not to mention the nine additional minutes it would take the streetcar to cover the same distance.

I am a transit supporter and user and think transit is very important for St. Paul and the region. I don't feel this is going to be a transit project benefiting transit users if the streetcar option is chosen.

There are two things that are important for building transit ridership: frequency and speed. The streetcar does not deliver the speed. There's a reason why the streetcar was dumped in the 1950s — high cost to maintain and it slowed down all street traffic. To recommend the streetcar makes the proposal seems like it's a development project that is using transit as a cover. I feel like this study is a sham to justify streetcar when it doesn't even use the original B-Line BRT numbers. Let alone the million and a half to study this topic again for the second time.

To invest large dollars in the region's transit system is a good thing, but I think we can be more efficient on how we do it. If BRT is really \$75 million for a line, let's have two lines, one from St. Paul to MOA and the other from 46 street station through the Ford plan and to downtown St. Paul. And if you want real estate development, then invest \$500 million along West Seventh straight out.

More funds are needed for development of regular routes to give frequency and speed to the whole system. That's the elephant in the room — dedicated funding for the operation of the transit system. It's easier to get capital dollars for building infrastructure but the operation of bus service is a bigger issue.

Bottom line, I endorse the Riverview Corridor #2 Arterial BRT — cost-effective, easily added onto for a fraction of the price.

I would like to know how you will vote on this important subject.
