Mr. Gade did call customer service in May 2024 and no one canceled his account at that time. Again I can see no reason why his account was reopened in Aug 2023 after being canceled.

So after looking this all over let me know how to proceed with adjusting the Gade account - what can I still reverse off of the St Paul Holding account and what if any quarter's did Paw La pay and then I would just need to credit his account.

FYI at no time has Paw La called customer service questioning any of the certifications.

I see you sent a NNP to Michael in Iowa, but he has not owned the home since August 2023. Please send photos showing verification of how many carts are at the property.

In looking at Michael Gade's account - every week it states "96 gal cart not out for service" and that is what we are billing that account for.

When looking at Paw La's account - it shows us dumping only a 64 gal cart – and that is what we are billing him for . So I would say there is only one cart here.

One of Paw La's letters is in the attached file -page 2221 I believe

3rd Qtr is the only time that we have sent Paw La's account for certification.

Again I have no idea why customer service canceled Michael Gade's account and then reopened it in August 2023

Below is his billing from that time frame forward

3rd Qtr 2023 – Billing for a 96 gal trash cart, taxes and one finance charge. Plus his unused service credit for service after 8.6.23.

He paid \$17.26 which is technically what he owed for service from 7.1.23 to 8.6.23. So this quarter was okay - no certification amount was sent
