Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, May 18, 2011 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that on March 28, 2011, a clerk working at the West St. Paul BP, Inc. sold tobacco products to an under age person in violation of Minn. Stat. § 609.685 and Saint Paul Legislative Code 324.07 (c). This matter has been placed on the public hearing agenda portion of the City Council meeting during which public discussion is allowed. This is a second violation since December 7, 2010, so the licensing office will recommend a \$400.00 matrix penalty.
