Please take notice that this matter has been set on the Public Hearing Agenda for a City Council meeting on **Wednesday, April 18, 2018 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed are copies of the email you sent on February 26, 2018 indicating that you were not contesting the facts related to the incident, but were requesting the opportunity to address the Council regarding the penalty, the resolution and any supporting documents. This information will be presented to City Council for their consideration.

This is an uncontested matter concerning the notification that the Department of Safety and Inspections (DSI) received from Ramsey County on November 1, 2017 which stated that the building had been secured and you had been locked out since August 3, 2017 for non-payment of back taxes. In addition, on December 21, 2017, DSI received a notice that your liquor liability insurance had been cancelled effective November 25, 2017. Finally, as of February 13, 2018, the Fire Certificate of Occupancy for the licensed premises had been revoked and the building was now classified as a Category 2 Vacant Building.

As a result, the licensing office will recommend revocation of Entertainment (B), Liquor On Sale-2AM Closing, Liquor On Sale-100 seats or less, Liquor On Sale-Sunday licenses and Shared Parking Agreement.
