Hi Char

I have reviewed your property history. In the City of Saint Paul, all homes with 1-4 units are required to have active garbage service per city ordinance. Service holds cannot be backdated because the hauler has been attempting to service your property. However, because the Quarter 1 billing cycle just started, I am able to adjust the bill before print and have backdated your hold to January 1 instead of the original start date of January 23.

If you would like to dispute the charges, you would have to attend a legislative hearing. The Quarter 3 hearing is currently scheduled the morning of March 5, and the legislative hearing for Quarter 4 is on May 14. If you would like to attend one or both of these hearings, please respond to this email. Also, you will get a delinquent notice for Quarter 3 in the next few days. There are no late fees added to the balance.
