* Project/Program Description In October 2012, a Saint Paul Police Officer was shot and seriously injured while on duty (the suspect was also shot and killed). A surveillance camera captured the incident on video but it was very difficult to see important details. We

brought the video to Target's Forensic Video Analysis Unit in Brooklyn Park and they were able to enhance it.

We understand the importance of Forensic Video Analysis and are in the process of expanding our capabilities. This training will allow us to expand our team's knowledge to better assign appropriate resources. Since surveillance video has become more cost effective and better quality, the need to effectively analyze it will only grow in the future.

* Project/Program Description Saint Paul Police Department (SPPD) special investigations unit (SIU) provides support for gathering evidence on crime circuits or criminal activity across multiple activities at the department. While the SIU develops evidence for varied crime activity, their work frequently includes focusing on investigation of sophisticated shoplifting rings.

SIU employs multiple technologies when developing evidence for building a legal case. This includes using portable cameras linked to CCTV systems, and reviewing cell phones and computers for text messages and other details related to a case.

Finally, the internal hard drives are used to copy files from recovered cell phones or computers for use in building a case.
