Chris,

My letter to Mr. Hanson dated January 30th outlined the conditions he needs to meet or present to the Legislative Hearing Officer next week. The matter has been continued several times to give him an opportunity to come up with plans if he intends to rehabilitate the building. Now that the code compliance report is completed, you should be able to help him bring forth plans and financing for the rehabilitation.

As to the dept's record, the \$5,000 performance deposit was posted on 12/26/18; therefore, there is no need to post another one at this time. Note. This was not one of the conditions in my January 30th letter.

You may use the sample affidavit I provided to address the financing capacity, as well as financial documentation for the project.

This is an informal hearing setting and a number of appeals are heard in each hearing session. For these types of cases, it starts at 9:00 a.m. on Tuesday, so we will not be able to accommodate your preferred date. If presented information/conditions are met, the hearing officer will develop a recommendation for Council consideration.

Is that required for the meeting and are we able to just use the sample you provided?

If its convenient to meet with someone at that time I would like to go over the process as I am not overly familiar with any additional requirements that may be needed with this being a vacant building. 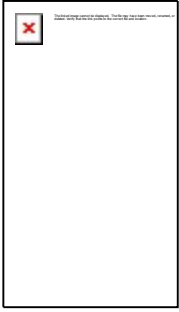
