NOTICE OF INTENT TO DENY LICENSES

Dear Mr. Murdick:

The Department of Safety and Inspections will recommend denial of the Food Vending Machine and Food Vending Machine Operator license applications submitted by The Vending Doctor, Inc. d/b/a Hospitality Vending for the City of Saint Paul. The basis for the recommendation is based on the following information:

On February 10, 2011, you were sent a letter from the Department of Safety and Inspections (DSI) indicating that your license applications were "pending" until you contacted DSI to obtain Environmental Health inspection approval.

You were given until February 18, 2011 to contact DSI to schedule the inspection. As of today's date that inspection has not been scheduled.

As a result, the Department of Safety and Inspections is recommending license denial and <u>immediate</u> removal of all Food Vending machines under your control from within the Saint Paul City Limits.

At this time, you have three options on how to proceed:

1. If you wish to admit the facts but you <u>contest</u> the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by **Friday, April 22, 2011.** The matter will then be scheduled before the City Council for a public hearing to determine whether to deny your licenses and order immediate removal of all of your Food Vending machines in Saint Paul. You will have an opportunity to appear before the Council and make a statement on your own behalf.

- 2. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (ALJ). At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation. If this is your choice, please advise me no later than Friday, April 22, 2011, and I will take the necessary steps to schedule the administrative hearing.
- 3. You may withdraw your license applications. Send a written statement to that effect to the Department of Safety and Inspections at 375 Jackson Street, Suite 220, St. Paul, Minnesota 55101-1806 no later than Friday, April 22, 2011. Information should be directed to the attention of Christine Rozek. Any request for a refund of the license application fee must also be made in writing to the Department of Safety and Inspections.

If you have not contacted me by Friday, April 22, 2011, I will assume that you do not contest the denial of your licenses and removal of all of your Food Vending machines in Saint Paul. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
