Dear Mr. Roston:

Legislative Hearings were conducted before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant an additional 180 days for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for **Tuesday**, **August 11**, **2020** at **10:00** a.m. via **telephone** at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions. Please reach out to me with your phone and call will be made between 10 and 11:30 a.m.

If your client has received your Certificate of Code Compliance by August 11, 2020, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If your client has *not* received her Certificate of Code Compliance by August 11, 2020, she will need to contact Joe Yannarelly (joe.yannarelly@ci.stpaul.mn.us or 651-266-1920) to schedule an inspection to occur *prior to* the week of August 11, 2020. Both Mr. Yannarelly and a building inspector will conduct this inspection.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, August 26, 2020 at 3:30 p.m. remotely.
