Location: Mississippi River Blvd and Summit Avenue

Noise Source: Team Ortho Foundation has requested a sound level variance to provide the use of a sound system for announcements and amplified outdoor music for the Monster Dash Event. The variance is requested for the hours of 8:30 a.m. until 10:00 a.m., with a pre-event sound check at 8:15 a.m. at Mississippi River Blvd and Summit Avenue on Saturday, October 29, 2016. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:30 a.m. to 10:00 a.m., with a pre-event sound check at 8:15 a.m. at Mississippi River Blvd and Summit Avenue on Saturday, October 29, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 a.m. on the date of the event.

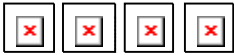
