I will be teaching on the evening of the hearing and be unable to attend. Here are comments on the proposed preliminary platt (subdividing the one property at 589 Burlington into 7 parcels) and the impact on our neighborhood.

A primary factor in our choosing this neighborhood to live in was that this area has historically been a place in the city that has been relatively less developed. The peaceful wooded spaces that are home to wildlife give Burlington Heights & Highwood their distinctive character that is so valued by its residents. While we respect the property owner's right to sell off their land, it is nevertheless sad for us to see one of the few remaining larger plots in the neighborhood being reduced to this after having contributed to the character of the neighborhood for nearly 100 years since the house was built in 1915.

Subdividing the property with the intent of adding 6 new housing units in addition to the current house may appear to add to the tax base of the neighborhood. Certainly it will increase traffic on a road where many people walk their animals, bike, and rollerski in the evening. It will likely also depress the value of surrounding properties as the attractiveness of the neighborhood is to a considerable extent its distinctive, peaceful character which will suffer from this development.
