41. Resolution – 10-1130 – Approving adverse action against all licenses held by Kim Huoy Chor Asian Cuisine, 1664 University Avenue.

Rachel Tierney, Assistant City Attorney representing the Department of Safety and Inspections (DSI), gave a staff report. She said the situation was unique in that licensing had never asked for license revocation based on environmental health. She reviewed the code citations and referred the Council to the inspection report. She said the penalty recommendation was based on the serious repeated violations.



The following appeared in opposition:

Jay Benanov (111 E. Kellogg Boulevard W., #310) appeared representing the owner. He said they were not disputing the facts but were asking that the Council not impose a “death sentence.” He said changes had been made, and they did not feel it was right to deviate from the matrix. He said the owner understood the seriousness of the situation and knew this was a last chance.

Vutey Tang, business owner, apologized to the Council and outlined new procedures and equipment. He said the business employed thirty people, used local vendors and paid local taxes, and he asked that the Council find another solution. He said he believed the complaints were from a disgruntled former employee and he provided a petition of support from customers and neighbors.

The new general manager introduced himself, and reviewed his experience and the changes implemented.

Councilmember Stark moved to close the public hearing. Yeas – 4 Nays – 0

Councilmember Thune asked Mr. Benanov to suggest an alternative penalty. Mr. Benanov suggested the penalty be imposed but stayed.

Councilmember Thune said the Council’s function was not to shut down businesses. He suggested that allowing the business to operate under conditions agreed to by Environmental Health and under close scrutiny would serve to correct rather than punish.

Councilmember Stark said he agreed with that sentiment but the restaurant had been given many chances, and DSI was suggesting an unprecedented penalty based on unprecedented conditions. He said the Council also had a responsibility to protect public health.

Councilmember Carter said inspection records and photographs showed a business that was flawed at its core, and he was leaning towards Councilmember Stark’s position in spite of community support for the restaurant.

Council President Lantry said it was clear the owner took the situation seriously, but should have two years ago. She said City staff had made every accommodation to help make the restaurant successful, but it didn’t appear they could be.

Councilmember Stark agreed. He asked whether a new violation after a stayed penalty would result in automatic revocation or another hearing before Council. Ms. Tierney said the violation would come back before Council.

Mr. Benanov said the owner was willing to pay the costs for additional City inspections on whatever schedule the Council imposed.

Councilmember Thune said he would still like to check with licensing on the practicality of determining whether the restaurant had come into compliance. He asked whether a one-week layover would allow licensing to report back on the practicality of that and with suggestions for the business to reimburse the City for the costs.

Ms. Tierney suggested a one week layover for licensing to meet with the owner to discuss license conditions, possibly including an inspection schedule and increased fees. She also suggested that an inspection be conducted the following day.

Councilmember Thune reiterated his desire to find a way to allow the business to stay open.

Councilmember Carter said he would support a one-week layover but would still have serious concerns even if there were a perfect inspection at this time, given the history.

Councilmember Stark moved a one week layover, with the conditions that an inspection be scheduled as soon as possible and a meeting scheduled between licensing and the property owner.

Ms. Tierney clarified that DSI might come back after one week with a recommendation of revocation if an acceptable compromise was not reached.

42. Resolution – 10-1131 – Ratifying the 2010 Right-of-Way Maintenance Program.

John Maczko (Public Works) gave a staff report. He said Public Works was recommending ratification of the 2010 fees which were proposed last fall and represented a 6.8% increase. He described the services covered by the fees, and said 2010 spending was in line with projections.

The following appeared in opposition:

Matt Anfang appeared representing the St. Paul Business Owners and Managers Association (BOMA). He commended staff for their work on the fee structure and said progress had been made on breaking down the fees and on the expected level of service provided for the fees. He said BOMA would be active in challenging the discrepancies in the way residential versus business properties were charged as well as discrepancies in the way downtown properties were charged. He said they were encouraged by the new accounting system Public Works would be implementing, and they were committed to partnering with the City to provide services in a cost-effective, efficient manner.

Gretchen Heinen (420 Herschel Street) said she was speaking on behalf of commercial property owners in St. Paul and asked for reconsideration of the increase, because not all commercial

property owners were making money. Angela Anderson submitted a written proposal.

Mike Schumann, Traditions Home Furnishings (1037 Grand Avenue) said he was speaking on behalf of owners of commercial properties located on corners. He questioned the legality of assessing the corner property owner for the alley access for everyone on the block, and he suggested that commercial properties be assessed in the same way as residential.

Lynda Rhodes (374 Wheeler St. N, #1) said she had purchased a condemned building on a corner lot and brought it up to the standards of the Minneapolis St. Paul Tour of Homes. She said if the City was going to charge they should provide the services for which they were charging. She provided photographs of her poorly maintained boulevard.

Scott Hesselgrave (1896 Ames Avenue) said he'd purchased a five-plex on the East Side in 1999. He spoke about the rate increases since then, and said that as a commercial property owner on a corner lot he paid nine times what his neighbor did. He said he had put a lot of money into the property and maintained it well, but was no longer able to make money. He said the City was pushing good landlords out.

Tony Voh (with Dong Vo), Stryker Auto Service (542 Stryker Ave.), said the discrepancy between residential and commercial property assessments was unfair. He said the previous year's 6.35% increase should be taken into account when considering the current increase. He asked the Council to think about the way corner properties were assessed.

Pao Lee Vang (1324 Payne Avenue) said he owned commercial and residential properties, and the charges for the commercial buildings were more than triple those of the residential. He said commercial buildings provided jobs and revenue, and he asked the Council to reconsider.

Danli Wong (1482 Arlington Avenue E.) said she had purchased three residential properties and brought them up to standards. She said she was not there to oppose the increase but to ask that the sidewalk be repaired.

Jamal Musse (767 Reaney) said his income as low, and his has assessment had increased from \$144 to \$154 with no increase in services.

Councilmember Thune moved to close the public hearing. Yeas – 4 Nays – 0

Council President Lantry asked how long there had been a long side subsidy for corner residential properties and full charge for corner commercial properties. Bruce Engelbrekt (Public Works) said he wasn't sure when it had originated and it had been at least eight years. Council President Lantry asked what amount of front footage would be lost if the city only charged for one side of the commercial properties. Mr. Engelbrekt said he couldn't venture a guess but it was a significant amount.

Councilmember Stark said it had been suggested that costs could be spread among the commercial properties on a commercial block. He said it was a policy question that should be discussed.

Councilmember Thune asked whether it was a legal issue given that ROW charges were supposed to be based on service provided. Assistant City Attorney Gerald Hendrickson said the current policy was legal but there were other options.

Mr. Engelbrekt said a starting point would be to take a sample area and calculate the additional costs to other properties if corner commercial lots were charged for only one side.

Councilmember Carter concurred that it was a complicated issue and one that merited discussion.

Council President Lantry said that what was before the Council was the rate. She said it was clear the Council members were interested in revisiting the policy.

Councilmember Carter moved approval.

Councilmember Stark said the rate for commercial properties was based on the assumption that there was more street use associated with commercial than residential. He also noted that the fees covered plowing and street sweeping as well as street repair, and costs for those services naturally increased over time.

47. Resolution Ratifying Assessment – 10-1135 – In the matter of improving the area referred to as the Hoyt/Kennard Residential Street Vitality Project area, by constructing new bituminous surface streets with concrete curb and gutter, concrete driveway aprons and outwalks, boulevards landscaped with sod and trees, a new lantern style lighting system, and all other necessary work to complete the project for the area surrounded by Larpenteur Avenue East on the north, White Bear Avenue on the east, Arlington Avenue on the south, and Hazelwood Street on the west.

The following appeared in opposition:

Pete Kalal (1734 California) said the project looked great. He asked that the Council reconsider the 5% interest rate for spreading the payments over 20 years; he suggested a 2.5% rate.

Councilmember Carter moved to close the public hearing.      Yeas – 4      Nays – 0

Councilmember Carter asked how interest rates were set. Bruce Engelbrekt, Public Works, said the Council approved the interest rates every year in January or February based on the City's cost of borrowing when bonds were issued plus a small amount for internal administrative costs.

Councilmember Carter moved approval.

A vacant buildings file was opened on June 28 and the building was reoccupied at the beginning of July. Ms. Moermond noted that Mr. Staeheli said he had directed questions regarding vacant building status to DSI staff and regarding building occupancy to someone in DSI administration. She said the items in play were the vacant building fee and whether a code compliance inspection should be required for reoccupancy. She said the building had been reoccupied while still condemned from the first fire and without a code compliance inspection or Certificate of Occupancy, and she didn't feel it was consistent with the spirit of the city code to grant additional time. Ms. Moermond said her recommendation was to deny the appeal and require a Certificate of Code Compliance for occupancy.

The following appeared in opposition:

Property owner Ronald Staeheli (353 Meadow Green Drive, Davenport, FL) stated that there had not been a fire in March and the house was condemned because a tenant had stopped up the toilet, removed the smoke detector, and called the City to complain. He said all repairs were made in April but he hadn't been able to get an inspector out to reinspect. He provided copies of receipts for the work. He'd been planning to rent the property on May 15, but there was a fire in the basement on the 14th. He painted and cleaned and was ready to move tenants in again when he noticed the placards. He said he received the vacant building notification; he read from the letter that if the building was vacant due to a fire he should return the registration within 30 days. He reviewed his correspondence with City staff from the time of the placarding until tenants moved in, including faxing in the vacant building registration, and said he felt he'd been in compliance. He said the fire exemption was something a property owner claimed and did not have to apply for; he read from the fire exemption form.

Ms. Moermond reviewed her notes from the hearing and confirmed that Mr. Staeheli was correct that there had not been a fire in March.

Councilmember Carter moved to close the public hearing.      Yeas – 4      Nays – 0

Councilmember Carter asked whether the fact that the initial condemnation was not due to fire

changed Ms. Moermond's recommendation. Ms. Moermond said she had developed the recommendation in the hearing room when the accurate information was before her and it still made sense to confirm that building was currently code compliant. She noted that the building was reoccupied without a Certificate of Occupancy and there was some culpability in that.

Council President Lantry read from the hearing minutes that Inspector Martin had made a reinspection on May 15. Ms. Moermond reviewed inspection records and said the May 15 date was an error. She said given the quality of the records from the hearing she would ask that the matter be laid over for two weeks so a Certificate of Occupancy inspection could be conducted..

Councilmember Carter moved to lay the matter over for two weeks.
