REMOVE IMPROPERLY STORED OR ACCUMULATED REFUSE INCLUDING: GARBAGE, RUBBISH, LOOSE AND SCATTERED LITTER, DISCARDED FURNITURE, APPLIANCES, VEHICLE PARTS, SCRAP WOOD AND METAL, RECYCLING MATERIALS, HOUSEHOLD ITEMS, BUILDING MATERIALS OR RUBBLE, TIRES, BRUSH, PALLETS, TARPS, PLASTIC CONTAINERS/BUCKETS, CLOTHING, TOWELS, BED FRAME, HEAD/FOOT BOARD, SCRAP PLASTICS, MACHINERY, CEMENT MIXER, IMPROPERLY STORED TOOLS, FULL PLASTIC TRASH CANS, HARD HAT, FULL BLACK TRASH BAGS, PLASTIC BAGS, METAL RACKS, FOAM PADDING, CONCRETE/CINDER BLOCKS, BUILDING MATERIAL, BRICKS, LOGS, CONTAINER FULL OF ROCKS, IMPROPERLY STORED CLOTHING, ETC., FROM REAR YARD AREAS.

STORED MATERIALS. IT SHALL BE UNLAWFUL TO ACCUMULATE AND STORE BUILDING MATERIAL, LUMBER, BOXES, CARTONS, PORTABLE STORAGE CONTAINERS, INTER MODAL CARGO CONTAINERS OR OTHER CONTAINERS, MACHINERY, SCRAP METAL, JUNK, RAW MATERIAL, OR FABRICATED GOODS IN EXTERIOR PROPERTY AREAS ON RESIDENTIAL PROPERTIES. REMOVE ALL IMPROPERLY STORED ITEMS THAT DO NOT BELONG OUTSIDE IN YARD AREAS FROM THE PROPERTY OR STORE IN A PROPER LOCATION SUCH AS SHEDS, GARAGES, CLOSED GAZEBOS, CLOSED PATIOS, BASEMENTS, CRAWL SPACE, ATTICS, CLOSED PORCHES, HOUSE, ETC UNTIL IT IS READY TO BE USED. Comply before September 6, 2017

If you do not correct the nuisance or file an appeal before September 06, 2017 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
