Your building was inspected on June 7, 2019, for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code.

A reinspection will be made on June 28, 2019 at 12:30 PM or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

- 1. Exterior Front Stairs SPLC 34.09 (3), 34.33(2) Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. This work may require a permit(s). Call DSI at (651) 266-8989.-The front and back stairs are in disrepair. Also, repair the back sidewalk.
- 2. Exterior House SPLC 34.09 (1)(2), 34.33 (1) Provide and maintain all exterior walls free from holes and deterioration. All wood exterior unprotected surfaces must be painted or protected from the elements and maintained in a professional manner free from chipped or peeling paint. -All around the house there is chipping and peeling paint and damages to the soffits, fascia and the gutters. Especially there is a section of the fascia that is sticking out.

- 3. Exterior House SPLC 34.12 (2), SPLC 34.36 (1) Repair and maintain all required and supplied equipment in an operative and safe condition to properly and safely perform their intended function in accordance with the provisions of the applicable code. -(NEW) The awning on the side of the house is ripped.
- 4. Exterior House SPLC 34.08 (2) Provide and maintain the property grade to slope away from the building to minimize the accumulation of water near the building. This work may require a permit(s). Call DSI at (651) 266-8989. (New)The gutters are damaged and there is a section that has a hole in it. (New) There are downspouts that have disconnected.
- 5. Exterior Roof SPLC 34.09 (2), 34.33 (1) Provide and maintained the roof weather tight and free from defects.
- 6. Exterior Interior Windows SPLC 34.09 (4), 34.33 (3) Repair and maintain the window in good condition. -The top window at the front of the house is in disrepair and there is a cellar window (new) that has chipping and peeling paint on it.
- 7. SPLC 40.06 Suspension, revocation and denial. (a) Grounds for revocation. The fire code official may, in writing, issue a notice to the owner(s) and known interested parties of the city's suspension or revocation of a fire certificate of occupancy issued under the provisions of this code, or deny an application therefor: (3) If it is found upon inspections of the fire code official that the building or occupancy is in violation of provisions of this or other applicable safety codes, ordinances, rules and regulations:-The Fire Certificate of Occupancy has been revoked due to noncompliance with the Legislative Hearing Officer's orders.
- 8. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
