WHEREAS, Brasa 2 LLC d/b/a Brasa Rotisserie, located at 777 Grand Avenue in Saint Paul, has 4 requested a waiver of the 45-day notice requirement for issuance of a liquor outdoor service area (patio) 5 license, an on-sale wine license, and a on-sale malt (strong) license; and

WHEREAS, the Summit Hill Association, has agreed to the waiver of the notice requirements; and

WHEREAS, 86 residential properties are within a 300 foot radius of licensee's proposed patio, and 10 licensee has obtained consent from 48 of those properties (56 %); and

WHEREAS, licensee sent two separate mailings and knocked on several doors in order to obtain 13 signatures from the remaining residences but was unable to contact them and received no negative 14 responses to the request for consent; and

WHEREAS, the Council finds that these efforts constitute a good faith effort to fulfill all petition 17 requirements, and that the results of the attempts to obtain signatures showed a generally favorable 18 disposition from the surrounding community toward the proposed licensed activity; and

WHEREAS, the Council finds that issuance of the license will not interfere with the reasonable use 21 and enjoyment of neighboring property and residences and will not bear adversely on the health, safety, morals and general welfare of the community; and

WHEREAS, the Council finds that the application is in order and there are no grounds for denial of 25 the license and that the failure to grant the waiver and the consequent delay in approving the license would 26 cause exceptional and unusual hardship to the license applicant; and

WHEREAS, the licensee agrees that in the event a complaint is received prior to the expiration of 29 the 45-day period and the complaint provides a basis for adverse action against the license, that the 30 Department of Safety and Inspections may direct the licensee to immediately discontinue all operations 31 until a public hearing is scheduled, and that the licensee shall comply with said directive; now, therefore, 32 be it,

33 34 RESOLVED, that the 45 day notice requirements of § 409.06 of the Saint Paul Legislative Code are hereby waived and a liquor outdoor service area (patio) license is issued to Brasa 2 LLC d/b/a Brasa Rotisserie, located at 777 Grand Avenue in Saint Paul, subject to the agreement stated above.
