That's what happens when the previous owner (or renter) doesn't pay their bill.

Old owners account was in the name of Gina Devito -

Poor payment history - every quarter was sent to the city/county for certification since the account came over from ADS in Jan 2022.

We did have a forwarding address on her account so any notifications were sent to Gina.

This is her 3rd Qtr Billing 64 gal trash service, taxes and 3 finance charges plus extra charges.

Gina's account was canceled as of 4.13.24 – that is the cancellation proration that you see in yellow

The bulk charges were called in by a William – there were a bunch from 4.3.2024 and another bunch on 4.30.24

They had already used up the free bulk in March 2024. So they were too late to make the 4.5.24 invoice.
