Please take notice that this matter has been set on the Public Hearing Agenda for a City Council meeting on **Wednesday, July 19, 2017 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed are copies of the resolution and supporting documents which will be presented to City Council for their consideration. This is an uncontested matter concerning the fact your client failed to submit the required Video Surveillance Plan to the Department of Safety and Inspections by the December 31, 2016 deadline imposed by City Council on December 7, 2016 (RES PH #16-426) in violation of license condition #1. In addition, your client's security staff failed to wand patrons as they entered the license premises in violation of license condition #2.

This is the third (3rd) violation to the licensee's conditions with the past eighteen (18) months; therefore per Saint Paul Legislative Code § 310.05 (m) (1) the licensing office will recommend a \$2,000.00 matrix penalty and a ten (10) day suspension of all licenses.
